I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE THE **Blue Knights International** Law Enforcement MC, Chapter II FOR ANY INJURY RESULTING TO MYSELF OR MY PROPERTY ARISING FROM, OR IN CONNECTION WITH THE PERFORMANCE OF THEIR CHAPTER DUTIES IN SPONSORING, PLANNING OR CONDUCTING THE EVENTS.

I am experienced in and familiar with the operation of motorcycles and fully understand the risks and dangers inherent in motorcycling. I am voluntarily participating in the **Officer Down Memorial Ride** and I expressly agree to assume the entire risk of any accidents or personal injury, including death, which I might sustain to my person and property as a result of my participation in the event, and any negligence (except willful neglect) on the part of any or all of **Blue Knights International** Law Enforcement MC, Chapter II in performing their chapter duties.
